Our guarantees to Local Authorities

- 1. A swift and uncomplicated referral process, with a designated member of our Public Sector Team as your point of contact throughout.
- 2. Councils will not at any stage be charged for our services. Where there are assets in an estate, we are usually paid for our work by way of a commission arrangement with the next of kin.
- 3. We will accept all referrals, regardless of the likely/estimated value of the deceased person's estate.
- 4. When the deceased person's estate is likely to be of very low to zero value, we will nevertheless make every effort to locate one family member, and report back to you with their details without delay. If a referral is received at a sufficiently early stage, we would hope to trace a family member in time for them to have the option of attending the funeral, or to make their own preferred funeral arrangements.
- 5. When an estate's value is estimated at approximately £5,000 or above, we will immediately initiate a full and thorough search for a Will. Should a valid Will be located,

we will provide you with details of the deceased person's executors.

- Progress updates provided at a regularity according to your preference.
- 7. In cases of intestacy, we will recommend the family member acting as Administrator to instruct one of our panel of independent solicitors who are highly experienced in estate administration; the solicitor will contact you to request any details you may have of the deceased's assets and liabilities, and will relieve you of any administrative burden as soon as possible.
- 8. Once a Grant of Letters of Administration has been obtained on behalf of the Administrator, the solicitor will prioritise the reimbursement of the Local Authority for any costs or administrative expenses incurred during their involvement at the earliest possible stage of the administrative process.
- 9. We are happy to offer a Service Level Agreement detailing the service and quality standards expected in public sector procurement, which can be adapted to your requirements.

The very nature of our work means our initial contact with a potential heir is frequently unexpected; the first reactions of a family member can vary from confusion and suspicion to fascination and excitement.

All Hoopers employees who engage directly with the public are highly trained. Every member of staff is salaried and does not receive any additional commission-based incentives.

Our code of conduct is very simple: to treat family members with the utmost respect and care. Advantages of referring to more than one genealogy company

Local Authorities are regularly inundated with Freedom Of Information (FOI) requests demanding information about their procurement and selection of genealogy services. The obligation to reply to each and every request necessitates a considerable allocation of time and resources.

Many Councils refer cases to more than one firm of genealogists on a rotational basis. Hoopers endorses this approach as an effective method of responding to such FOI challenges. We would recommend that achieving the appropriate ISO 9001 and ISO 27001 certifications should be a requirement for any company to be included in the rota. From a quality assurance point of view, the Local Authority is able to compare and contrast the performance and efficacy of each firm they refer to, and has the option to cease referrals to any company which falls short of expectations.

Government Legal Department (Treasury Solicitor) referral policy Recent years have seen significant changes to the Government Legal Department's (GLD's) referral policy.

As stated on the official gov.uk website, the Bona Vacantia Division of the GLD does not deal with estates if "there are known or likely to be entitled relatives who survived the deceased, even if these have subsequently died, cannot be traced or do not wish to deal with the estate." Considering that a number of Local Authorities Hoopers regularly engages with have received information that 95 % of cases referred to genealogists result in the successful tracing of a family member, this precludes a vast majority of cases from being referred to the Government Legal Department.

A further change of policy has resulted in the GLD no longer liaising with an heir or their solicitor after admitting a valid claim - instead they direct the claimant back to the original source of the referral (in many cases, a Local Authority). The Bona Vacantia public notice concerning the estate will also include details of the source of referral, which may result in firms of genealogists or members of the public who believe they may be entitled making direct contact with a Council.

A combination of these factors has added considerably to the potential administrative burden faced by Local Authorities; for this reason, many have decided to refer such cases directly to Hoopers.

Fully regulated estate administration

Hoopers always ensure a solicitor, who would be subject to statutory regulation from the Solicitors' Regulation Authority, is instructed to undertake an impartial and independent estate administration process. This could be a solicitor with proven experience in this field recommended by us, or the solicitor of choice of the Local Authority or the family members concerned.

This is the only way to ensure the estate funds are entrusted to fully regulated professionals. An increasing number of probate genealogy companies now administer estates internally, but as our profession is not currently subject to statutory regulation, this can result in serious conflicts of interest.
